

IMPACT60, Inc. Build-A-Car for a Cause Raffle
1969 Restored Mustang
Official Rules

1. All entrants of the IMPACT60, Inc. Build-A-Car for a Cause Raffle (“Raffle”) must be 18 years of age, have a valid driver’s license, and be a legal resident of the 50 United States or the District of Columbia.
2. Raffle sponsored by IMPACT60, Inc. (Collectively “Sponsor”). IMPACT60, Inc. aka IMPACT60, is a 501(c)(3) charitable organization, with tax ID 82-4212924. All proceeds will benefit IMPACT60.
3. IMPACT60 Raffle Administrators are not eligible to participate.
4. Raffle tickets will be sold at \$100 per ticket. 1,000 maximum tickets will be sold. No limit is set on the number of tickets an individual may purchase, up to the maximum number of tickets available.
5. No additional purchase (admission, membership, etc.) is necessary to purchase raffle tickets.
6. Tickets sales will begin on Wednesday, March 13, 2019 at 6:00 PM and will be sold until Saturday, July 20, 2019 at 3:00 PM. Sales will take place until the maximum limit of 1,000 tickets is reached. Sponsor’s computer is the official time keeping device for this Raffle. If fewer than 400 tickets are sold by 3:00 PM on July 20, 2019, IMPACT60 may cancel the raffle in its sole discretion, and any participant who has previously purchased a raffle ticket will be refunded the total cost of each ticket purchased within 10 business days.
7. Tickets are non-refundable.
8. Ticket purchases may be made in person, by phone, or online. Accepted forms of payment include credit card or cash. Checks will not be an acceptable form of payment.
9. Entrants may enter by completing the raffle ticket with their name and contact information and placing it in the locked ballot box (“Designated Entry Box”). If purchasing ticket over the phone with a Raffle Administrator or online, Entrant entrusts the Raffle Administrators will process payment and complete their ticket with contact information as provided. If a ticket is purchased over the phone or online, ticket stub will be mailed to Entrant at the address supplied.
10. The Sponsor is not responsible for lost entries or unauthorized human intervention. All entries submitted become the property of the Sponsor and cannot be returned.
11. Entries which the Raffle Administrators determine, at their discretion, to be incomplete, incorrect, illegible, or not in accordance with these rules will be disqualified without notice to the entrant.

13. If, in Sponsor’s opinion, there is any suspected or actual evidence of fraud, tampering, or unauthorized intervention with any portion of this Sweepstakes, or if fraud or tampering of any sort compromises the integrity of the Raffle, Sponsor reserves the right to void suspect entry and/or terminate the raffle and award the prize in its sole discretion.
14. Entries must be purchased, received, and placed in the Designated Entry Box before the end of official raffle hours. Any attempted entry after official raffle hours will not be valid and will not be deemed eligible. The Sponsor’s computer is the official timekeeping device for this Sweepstakes.
15. Odds of winning depend on number of entries.
16. One (1) Winner will be randomly drawn from the entries received at 4:00 PM on Saturday, July 20, 2019. Drawing will take place at the Performance Classic Car Show in Delaware, Ohio. Winner will be notified by phone call and by e-mail with the phone number and e-mail address provided on the ticket form.
17. While reasonable attempts to notify the Winner will be made, it is the responsibility of the Winner to be available for notification. In the case where a Winner cannot be reached, a replacement Winner will be drawn. Winner will have 48 hours to respond and if they are not reached within those 48 hours, a new Winner will be drawn. The Sponsor is not responsible for and shall not be liable for late, misdirected, or unsuccessful efforts to notify a potential Winner. If the Winner chosen does not claim the prize within the appropriate time given upon notification or unless otherwise stated herein, the Winner will automatically be disqualified and their prize will be forfeited. No alternative prize will be substituted. Furthermore eligible entrants agree as follows: By participating, you agree (a) to be bound by these Official Rules; (b) as between you and the Sponsor, that the decision of the Sponsor is final on all matters relating to the Raffle; (c) you are

not participating on behalf of any employer or third party; (d) in the event that you do not comply with the Official Rules, then you will be disqualified.

18. In the event viruses, bugs, unauthorized human intervention, Acts of God, acts or regulations of any governmental authority, war, national emergency, accident, fire, riot, strikes, lock-outs, industrial disputes, acts of terrorism or other matters beyond the Sponsor's reasonable control, corrupt, prevent or impair the administration, security, fairness or proper play of the Raffle, so that it cannot be conducted as originally planned, except where prohibited by law, Sponsor has the right, in its sole discretion, to modify the Official Rules or to cancel, modify, terminate or suspend the Raffle; and in such event, to select a Winner by such method as Sponsor in its sole discretion shall consider equitable.
19. PRIZE - The prize will consist of a reconstructed 1969 Ford Mustang convertible (estimated retail value - \$40,000). The Winner is responsible for obtaining insurance on the vehicle. The winner must supply proof of insurance and valid Driver's License at the time of delivery. Winner may take delivery at any Performance Columbus dealership, including Honda Marysville, Performance Chrysler Jeep Dodge Ram Georgesville, Performance Chrysler Jeep Dodge Ram Delaware, or Toyota Direct.
20. **Winner must take delivery of the prize within 30 days of notice of winning.** The winner of the 1969 Mustang is solely responsible for all applicable taxes, insurance, and any and all other expenses not specifically listed herein that are incurred with winning the 1969 Mustang.
21. All decisions of the Raffle Administrators are final.
22. By entering the Raffle, entrants agree that IMPACT60 and Performance Columbus Family of Dealerships shall have the right, free of charge, to publish and/or broadcast by any means the name, city of residence, photographs, and statements of the Winner.
23. If a potential Winner cannot be contacted within 48 hours from the drawing, does not comply with these Official Rules, or does not take delivery of the prize in a reasonable time period deemed by IMPACT60, the potential Winner forfeits the prize. In any of these cases, another Winner will be drawn.
24. Should the potential Winner be deemed ineligible at the time of the drawing or subsequently at the time of delivery, according to the Official Rules, he/she will be automatically disqualified and will receive no compensation. No cash substitution, transfer, or assignment of prize will be allowed.
25. By participating, entrant agrees to release and hold harmless IMPACT60 and Performance Columbus, their affiliates, subsidiaries, and the directors, officers, agents, and employees from all claims or damages, in equity or in law, arising out of participation in the Raffle, as well as any and all liability arising from the acceptance and/or use/misuse of the prize.
26. The Winner will be identified online at www.impact60.org once the Winner is determined eligible to accept the contest prize and has executed the proper documentation.
